The goal of the program is to foster a greater awareness and protection of native Hawaiian ecosystems by supporting the college education of students from Hawaii studying in associated fields, with the hope that they will return to Kauai and further the cause of environmental conservation.

Annually, the organization announces an open scholarship process, accepts applications, and reviews them by a Selection Committee comprised of Board Members. Recipients are selected based upon best fit with the goals of the scholarship program, demonstrated passion for the mission of the organization and other criteria. The Committee recommends scholarship awards for the Board of Directors to review and approve. Once awarded, scholarships are applied directly to college or university expenses. The organization accepts gifts to support the restricted fund and, through a Board motion, adds to the fund when possible.
